

# MEMBERSHIP APPLICATION

Lead\$ of North Fresno is a member organization and a forum to network in a professional atmosphere. Sales professionals and business owners that sell PRIMARILY or totally to business enterprises are invited to apply. The group provides a resource of information for business professionals on topics of common interest. Through active participation, members can promote their own businesses, give presentations, and increase their visibility and exchange referrals.

# IMPORTANT Please read the membership procedures and guidelines:

- 1. Lead\$ of North Fresno expects a high level of commitment and participation among all of its members. Our membership process may be more thorough than other referral organizations. A prospective member's application is reviewed for content. Each applicant is interviewed by one or more individuals from our Membership Committee who then reviews the application with the entire committee.
- 2. Membership dues are \$175.00 per year. Breakfast dues are billed quarterly and paid in advance. Membership and breakfast dues are not refundable after membership approval. Dues are payable by cash or check. Returned checks are subject to a \$35.00 additional fee. Membership and breakfast dues must be submitted with the application. Checks will not be deposited until after membership approval.
- 3. Attendance is very important. You must be committed to attending weekly meetings.
- 4. We allow one business representative per category. Your business must not conflict or compete with any other member in the group. Some organizations have several facets, but you may only apply for and promote <u>one</u> open category as classified by Lead\$ of North Fresno. When approved, that becomes your 'protected' category.
- 5. If there is a conflict of business interest the current member will decide on new member acceptance if the new member's business infringes on the current member's 'protected' category.
- 6. **Membership is awarded on an individual basis, not as a corporate membership.** Members are responsible for payment of their own dues even if reimbursed or paid directly by their company.
- 7. Renewal dues and breakfast dues must be paid timely in order to retain membership standing.
- 8. Membership is not transferable to anyone else, except as outlined in the Lead\$ of North Fresno Bylaws.
- 9. Lead\$ of North Fresno reserves the right to decline membership to any individual or the company represented based on the business needs of the organization, or if a check for membership dues is returned.
